- 4. Commissioner Schwartz called for Board member discussion, questions and feedback on the proposed budget FY 2021-2022.

  - 1. Shellie Campbell updated the board on the current COVID-19 status.

- 2. Wasco County is currently moving to the lower risk category. Gilliam and Sherman remain in the low risk category.
- 3. OHA is releasing some funds for local communities support.
  - a. Local county Public Health departments are creating an Equity Plan to outline their plans for serving their vulnerable populations and communities.
  - b. The NCPHD Equity Plan has been submitted to OHA.
  - c. Once OHA approves the Equity Plan copies will be forwarded to all Board Members.
- 4. Schools and Successes COVID-19 Response presentation by Janelle Sandoz and Martha McInnes.
  - a. Janelle and Martha outlined the COVID-19 and vaccination response and successes for Wasco, Sherman, and Gilliam counties schools and districts.
- 5. Discussion, questions and feedback were requested.

#### 2. Director Hire Timeline

- 1. Commissioner Schwartz outlined the status and next steps for the hiring of the new NCPHD Director.
  - a. The position was posted and closes on June 11, 2021.
  - b. The Recruiting Committee will be setting up an initial meeting to review applicants.
  - c. The meeting will be an Executive Session and a PSA notice will be sent out as per requirements.

#### 3. Contracts Summary

- 1. **GASB 75 SERVICES AGREEMENT** between CIS Trust (CIS) and North Central Public Health District (NCPHD) to provide GASB 75 OPEB required services.
  - a. *Fiscal Impact:* Estimated cost to NCPHD of \$1,500. (This figure changes with the number of staff)
- 2. **LETTER OF AGREEMENT 2021** from Pauly Rogers & Co. to North Central Public Health District reviewing the work done for the financial audit review.
  - a. Fiscal Impact: None
- 3. **OREGON RHCARE MEDICAL SERVICES AGREEMENT** between Oregon Health Authority Reproductive Health Program and North Central Public Health District (NCPHD). This agreement outlines the conditions for being certified as an RHCare Agency with the State of Oregon, Oregon Health Authority (OHA), Reproductive Health (RH) Program and to receive payment for reproductive health services provided in NCPHD's clinic.
  - a. Fiscal Impact: No set fiscal impact. Any impact will vary with clinical services provided.
- 4. **1015198\_NCENTRAL\_AMENDMENT 2\_EXECUTED** is a Research Subaward Agreement between Oregon Health & Science University and North Central Public Health District regarding funds to be used to provide CACOON services.
  - a. Fiscal Impact: \$28,282
- 5. **OEM DR 4499 AMENDMENT #1** between the State of Oregon and North Central Public Health District (NCPHD) through the Oregon Military Department Office of Emergency Management. This amendment extends the deadline from the original contract.
  - a. Fiscal Impact: No fiscal impact.

## NCPHD Interim Directors Report for Board of Health Meeting of July 13<sup>th</sup>, 2021 Presented by Shellie Campbell, Interim Director

July 2021 was another action packed month for NCPHD staff. Here are the highlights...

COVID – Several changes took place.

- We pulled down The Readiness Center mass vaccination site and moved to mobile events.
- The VAX Team went out to Sherman and Gilliam County (Condon, Arlington, and Moro – 6 clinics in June).
- Wasco County welcomed a Mobile Vaccine Clinic from FEMA. The clinic came with a trailer, staff and vaccine. It has been well received and as of June 30<sup>th</sup> over 1,000 vaccinations had been given. One of the focuses of the MVC is to support getting migrant workers fully vaccinated while they are working in our community.
- Planning is underway to continue offering vaccine in underserved communities and populations. We have provided onsite vaccine clinics at Windy River Gleaners, Dufur School and Community Meal sites.
- Planning is also in full gear to address school vaccinations and recommendations as new information is received. We are thankful for the relationships that have been formed over the past 16 months to support the work going forward.
- We continue to move and plan with changes coming from the state and OHA. We are
  encouraged to see our vaccination numbers increase, but we also are aware that we
  have more work ahead of us and that COVID is not "over" and is unpredictable.

#### **NCPHD Programs**

- Our WIC program continues to provide one on one service to clients, mostly virtually.
   An interesting outcome from the pandemic is our client service numbers were very high even under challenging circumstances. WIC staff implemented a new outreach plan to provide over 500 Farmers Market Vouchers during the month of June with a "Drive-thru" pick-up process.
- Nurse Home Visiting has continued to provide services to pregnant and parenting families and children. The Team has also continued to support special need clients through the SPOC (Shared Plan of Care) with community partners.
- Environmental Health is moving to back in person inspections for restaurants, septic tanks and pools. The EH Staff are very busy. This past year has brought new enforcement challenges that no public health department has seen in previous years. We continue to work with our state partners to research and address.
- Walk-in Clinic and Reproductive Health continue to see clients by appointment. The clinic is also offering COVID Vaccine one day a week and look to expanding clinic hours as needed.

#### Staff Updates

• On June 30<sup>th</sup> we celebrated Kathi Hall, our Finance Manager, and her retirement. Kathi has worked at NCPHD for over 20 years and was instrumental in setting up the move from Wasco County to NCPHD District. Kathi has been invaluable to the

- success of NCPHD and helping us navigate the funding requirements and changes during the pandemic. We wish her all the best!!
- We are currently interviewing for two Communicable Disease Investigators. One for NCPHD and one for the Modernization of Public Health Regional Position. We are encouraged with the applicants we received. Jeremy Hawkins our current CD Supervisor is returning to school in September to complete his Masters in Public Health. Jeremy went above and beyond during his time here at NCPHD and led the COVID Team in testing, outreach, wraparound services and contact tracing. He is a public health rock star!
- We welcomed to our financial team Brita Meyer. Brita has roots here in The Dalles and we welcome her expertise in accounting, payroll and many other financial matters.
- Our staff at NCPHD put their personal life on hold during the past 16 months, we are pleased to see staff planning vacations and taking much deserved time off.
