simplification in the budgeting process in coming years as well as ease in creating financial reports.

- c. Martha McInnes, Director, focused on the Rede Group contract for NCPHD's Modernization plan. Proposed Fee Adjustment for Onsite Septic Program – FY 2025–2026

Environmental Health is proposing a fee increase for the Onsite Septic Program to take effect in Fiscal Year 2025–2026. This adjustment is based on recent changes at the state level and the need to address local operational costs.

The Oregon Department of Environmental Quality (DEQ) is implementing a 3% increase to the surcharge associated with onsite septic system services. This surcharge is a pass-through cost collected by NCPHD and remitted to DEQ to support their program operations and staffing.

In addition, NCPHD is proposing a 3% increase to the base onsite program fees to help offset inflationary impacts on staffing, materials, and operational costs. Please note, that NCPHD did not increase the base fee during Fiscal Year 2024–2025.

While each component, surcharge and base fee, will see a 3% adjustment, these increases apply to separate portions of the total fee. As a result, the combined impact on the total cost to the customer is approximately a 3% increase overall, not a cumulative 6%.

A fee table comparing Fiscal Year 2024 and proposed Fiscal Year 2025 fees is attached for reference.

Whereas, NCPHD is proposing a 3% increase to the base onsite program fees to help offset inflationary impacts on staffing, materials, and operational costs;

Whereas, The Oregon Department of Environmental Quality (DEQ) is implementing a 3% increase to the surcharge associated with onsite septic system services;

Whereas, Be It Resolved, the North Central Public Health District Board formally adopts an increase to the base fees for service and the DEQ surcharge, where it applies, by 3% as shown in the attached fee schedule.

NCPHD Contracts Summary for Board of Health Meeting of June 10, 2025

- **1.** C2025 Pauly, Rogers, & Co. Engagement Letter 2022-23: Initiating the process of annual fiscal audit required by CFR 200.501 for recipients of federal funding.
 - a. Fiscal Impact: \$25,500
- **2.** C2025 Pauly, Rogers, & Co. Engagement Letter 2023-24: Initiating the process of annual fiscal audit required by CFR 200.501 for recipients of federal funding.
 - a. Fiscal Impact: \$27,700
- **3. C2025 Quest Letter of Agreement:** Agreement with Quest to utilize them as our primary reference lab. This allows NCPHD to consolidate from 3 reference labs to 2, reducing errors and complexity for staff, and simplifying pricing for self-pay patients.
 - **a.** Fiscal Impact: Varies, but overall demonstrates improved pricing from our previous reference labs and thus positive fiscal impact.
- 4. C2025 Quest Pricing Agreement BV & CT-GC: Negotiated rates for specific lab tests
 - a. Fiscal Impact: positive fiscal impact, lowering costs for self-pay clients.

NCPHD BOARD OF HEALTH REPORT - JUNE 2025

Despite the Board approving only a quarterly update at our last meeting, I find it difficult not to highlight all the work staff is doing each month. At some point I hope to find an ideal cadence and appreciate the Board's flexibility to that endeavor!

The Leadership team made some adjustments to the interim Organizational Chart, shifting some administrative supervision duties for better staff support. Kate Hendershot took on Home Visiting, and Martha resumed primary supervision for the clinic.

With the budget process, end of the fiscal year annual reports and workplans for many Program Elements, and ongoing work requirements for Modernization, the administrative burden is significant this time of year. OHA is currently doing an assessment of administrative burden with the Rede Group, and preliminary reports should be available sometime this summer. We hope this report will offer insights into consolidating and simplifying administrative requirements from OHA.

Lastly, we await the legislative session results and the state budget, which will indicate potential financial changes for the upcoming fiscal year. While our budget has been outlined, it is an estimate as we lack definitive state information. Federal budget approval will also necessitate possible adjustments, making planning challenging. Despite these uncertainties, we remain dedicated to our community and our commitment to this work remains steadfast.

FOUNDATIONAL PROGRAMS

ENVIRONMENTAL HEALTH

NCPHD is pleased to announce Peter Xiong joined the Environmental Health team on June 2nd as a trainee. Peter brings a Master's degree in science, specializing in fisheries, wildlife biology, ecology, and conservation, and has relocated from Florida. We are thrilled to have him on board!

Paula and Heidi attended a two-day intensive Soil Science Workshop in Bend, Oregon. This training provides valuable knowledge about soils to enhance their work in the Onsite Septic Program.

After receiving approval from the Oregon Health Authority, we have begun aquatic facility (pool) inspections. Significant changes to the regulations in April 2025 required updates to the state's systems for completing these inspections. With 24 pools to inspect locally by the end of June, along with the busy season for temporary event inspections, the team faces a demanding workload. They will diligently work to complete these inspections while managing their daily responsibilities in the Onsite Program, and the Food, Pool, and Lodging program.

PREVENTION AND HEALTH PROMOTION

WIC - Maricela Elias-WIC Coordinator

WIC staff have been busy in May preparing for our two most significant events of the year: the Farm Direct Program and supporting our migrant population who come for the cherry harvest. Additionally, we held two outreach events. Cynthia and Veronica represented WIC at the Wasco County Children's Fair on May 17, while Janna and Maricela participated in The Dalles Middle School Carnival Event on May 20. Many families visited our tables to learn more about WIC services and expressed their gratitude for public health initiatives.

Farm Direct checks will be available to eligible recipients starting in June. We will kick off the season with a drive-through distribution day at our NCPHD parking lot on June 4th. Eligible

families can pick up their checks by visiting our office during business hours or by requesting that the checks be mailed to them. Additionally, we enjoy partnering with our local farmers' markets, so there will be in-person check distributions at The Dalles Farmers Market on July 12th and at Evans Fruit Stand on August 15th. Farm Direct Check distributions will be available while supplies last and will be on a first-come, first-served basis.

WIC held its traveling out-clinic to Moro on May 13^{th,} and immunizations were coordinated with for under-immunized WIC children. Thank you clinic staff!

We are ready to welcome our WIC-eligible migrant population. Based on information from our local growers, we expect most families to arrive in town during the week of June 9th. This year, WIC will return to in-person enrollment at the Oregon Child Development Coalition (OCDC), scheduled from June 11th to June 13th. Bilingual WIC staff will have a station at OCDC's enrollment event and will connect with families as they complete their Head Start paperwork to help facilitate the WIC transfer process, eliminating the barrier or driving and locating the WIC office.

Home Visiting - Lori Treichel, Home Visiting Lead

The Home Visiting team's May figures (70 visits as of press time) demonstrate exceptional performance. Approaching FY2025's revenue targets, they've achieved an 83% increase in the last two years, highlighting a strong commitment to program sustainability. This is especially critical given the growing trend of undervaluing and underfunding Family and Child Health programs. The team's efforts have significantly improved the lives of numerous families, leading to better outcomes for children and families in the community.

Tobacco Prevention & Education Program (TPEP) Coordinator – Neita Cecil Neita is diligently working on the following:

- Working on completing Tobacco & Alcohol Retail Assessments (TARA) in Wasco & Sherman Counties.
- Creating a tobacco cessation policy/procedure.
- Finalizing workplan for the coming biennium.
- Researching Pharmacy License options to possibly have NRT available in Sherman Co.

ACCESS TO CLINICAL AND PREVENTATIVE SERVICES – Martha McInnes, Director

In May, Clinical Staff actively served 41 clients and conducted outreach. Notably, on May 29th, they delivered reproductive and sexual health education to students at The Dalles Middle School, receiving very positive feedback, and collaborated with Gorge Access Project to assemble Plan B kits containing emergency contraception, pregnancy tests, condoms, and informational resources about pregnancy options.

On June 2nd, NCPHD and Columbia Gorge Pride Alliance co-hosted an open house to discuss making the clinic more LGBTQ+ friendly. Staff are now preparing for the Columbia Gorge Pride event in The Dalles on June 28th.

To enhance patient care, the clinic is actively working towards acquiring an ultrasound machine, meeting with vendors to choose the best option. Staff are also collaborating with vendors to redesign the clinic and lobby areas to improve their appeal and comfort for everyone.

Additionally, NCPHD has begun a year-long Quality Improvement project with OHA's IQIP (Immunization Quality Improvements for Providers - sponsored by the CDC) to boost vaccination rates for two-year-olds in the community.

COMMUNICABLE DISEASE CONTROL – Marta Fisher, Regional Epidemiologist

Over the past 2 years, the CD team has worked to strengthen partnerships school nurses and other school health personnel. Similarly, we would like to strengthen connections to daycares and preschools. We have 2 goals with this outreach. The first is to make childcare center owners aware that we can be a resource for them. We want them to know we're happy to provide infection control advice when they have a couple of sick kids, even when it is a not a situation where a specific public health intervention is required. Secondly, bolstering these relationships will help us collaborate more effectively with childcare centers when a situation arises where public health intervention is required.

Over the winter, multiple reports from the CD team discussed work we did to minimize the spread of pertussis (whooping cough.) This was part of a statewide, national, and possibly even international increase in pertussis. In 2024, <u>Oregon saw more cases of pertussis</u> than it has in any year since 1950. Pertussis illness seem to have peaked in January 2025, but do not yet seem to have returned to normal levels. Locally, we have continued to see a trickle of pertussis cases and we remain alert for community transmission.

FOUNDATIONAL CAPABILITIES (supporting all the foundational programs)

Leadership and Organizational Competencies

- The FY26 Budget process progresses with budget hearing and adoption today!
- We received the final FY22 audit report from Pauly, Rogers, & Co., as presented to the board and are working on a written response and plan for the audit findings. Simultaneously will begin our FY23 audit, utilizing some contract work for the extensive scanning required to transform all the past records to electronic format.
- The Policy and Procedure project is nearly complete with Phase 1, which provides organized policies, covering all our required topics. Phase 2 will involve the NCPHD team reviewing and revising the policies on a schedule over the next year to ensure they accurately reflect all that we do.

Health Equity and Cultural Responsiveness

Ongoing work in this area. We will be submitting our Health Equity Plan to the state, and the Leadership team will begin to strategize how to integrate the work in this plan with the rest of the plans we are required to submit.

Community Partnership Development

NCPHD engages in many local, regional, and state-level partnerships, examples including:

- Regional CHA/CHIP in collaboration with multiple agencies, led by Columbia Gorge Health Council
- Director is a voting member on the Columbia Gorge CCO Clinical Advisory Panel (CAP)
- Regular meetings with MCCFL, The Next Door, Hood River Health Department, NORCOR, and others.
- Hood River County Health Department
- Sherman County Medical Clinic
- Sherman County Prevention

Assessment and Epidemiology

See above in Communicable Disease Control.

Policy and Planning

- Martha sent communications to state and federal congressional representatives, advocating
 for increased public health funding and opposing drastic cuts to Medicaid that would affect
 the entire community.
- Martha is participating in our regional CHA workgroups to formulate the CHIP (Community Health Improvement Plan), focused on 4 main goal areas: Access to Healthcare, Access to Behavioral Health, Affordable Housing, and Workforce Development.
- Marta Fisher will participate in a state workgroup focused on Public Health Modernization Accountability metrics this summer.
- Neita Cecil, Monica Romero, and Maria Pena will be on the OHA Equity Grant review team, reviewing grant applications over the summer, impacting the grants and funding that will be focused in our area.

Communications – Mikey Goyette

Mikey attended a FEMA ICS training for PIOs (Public Information Officers) (L0105) on Public Information and Warning, over 2 days. This course is intended for new PIOs to provide basics of what a PIO does in an emergency.

- Working on cleaning up our Medical Reserve Corps (MRC) database, as SERV-OR has changed platforms.
- Participated in South County Strong Wildfire preparedness event in Maupin, and getting ready for the Get Ready preparedness event in The Dalles on Sept. 20 (Mark your calendars!).
- Building Stop the Bleed Kits to be shared with EMS agencies in Wasco & Sherman Co.
